ENTRY DEADLINE: All **paper** entries must be **RECEIVED BY November 11, 2017**. Space is limited. Late entries may be accepted with a \$15 late fee. **No** refund after the deadline. **No** entry will be accepted without an entry form and payment. **On-line registration** will be accepted until **November 12, 2017**.

ELIGIBILITY: A USATT sanctioned 3-star tournament. Proof of USATT membership required. Rating will be processed through USATT.

FORMAT: Singles events will start with a 3-way or 4-way preliminary round robin (RR) followed by a single elimination (SE) playoff. One or two players will advance from the preliminary RR depending on the number of entrants. Doubles events are single elimination. Format subject to change based on actual number of players.

EQUIPMENT: Nittaku 3-Star PREMIUM 40+ Balls, sponsored by **Paddle Palace**, will be used. Nine ITTF Approved Joola tables will be used. ITTF approved blue floor mat on all courts. (Non-marking shoes for players are required.)

ENTRY FEE: \$35 for Open Singles. \$25 for all other singles events. USATT membership fee \$49/yr for adult, \$45/yr for juniors, or \$20 one-time tournament pass.

RULES:

- ❖ All USATT regulations, including equipment, conduct, dress, and language, apply.
- ❖ All matches are best of 5 in games except quarterfinals, semifinals, and final of the Open Singles, which are best of 7.
- ❖ It is recommended that players bring two legal rackets and two distinctively colored shirts.
- ❖ Players must arrive at least 20 minutes before the event starting time.
- ❖ Ratings as of October 15, 2017 on the USATT website will be used to establish eligibility. The most recent rating will be used for seeding. Estimated ratings for new players will be accepted from USATT certified coaches for seeding purpose. Un-rated players may not advance from the preliminary rating events – NO EXCEPTION.
- ❖ Must be over 50 for the Over 50 events by November 30, 2017.
- ❖ All decisions made by referee or director will be final.
- ❖ Prize will be forfeited if the match is not played unless approved by the tournament director.
- ❖ Events may be canceled or combined if needed. In the event of cancellation, fees will be refunded.
