Eligibility: Open to all USATT, CTTA or any other ITTF affiliate members. Non-members must join the USATT to participate any sanctioned events. Membership may be purchased with your entry. You may be asked to show proof of recent membership if your name is not on the current USATT listing.

Deadline: All paid entries received by July 23th will be guaranteed participation. Entries received after the deadline may be accepted on a space-available basis. Cancellation will only be refunded if notification is given before July 22nd.

Check-in: Players should check-in as early as possible and should arrive **NO LATER** than 30 minutes prior to the starting time for their earliest event. (Note: The venue opens at 8:30am).

Singles events Format: All matches will be 3 out of 5 to 11 points

- All Singles events are round robin for the first round. Subsequent rounds will be single elimination.
- Top 2 players* from each group in the first round will advance to the next round.
Doubles only the top team will advance from to the next round

*** non-rated players are not allowed to advance in rating events except if the players have an established league rating (3 leagues at least)**

- USATT rules and regulations will be enforced.

Round Robin Format: All matches will be 3 out of 5 to 11 points

- **First Round:** players (60 max) will be snake drawn into RR groups of 6 players.
- **Second Round:** the top 2 finishers from each RR group will move into Division A, # 3 & 4 will move into Division B, # 5 & 6 will move into Division C. Players in each Division will be snake drawn into RR groups of 4 - 6 players.
- **Third Round:** The top 2 finishers from each group will advance to the Single Elimination of their division.

Event: Player may be removed from an event at any time should the Tournament Committee decide that the player is overqualified. The Tournament Committee also reserves the right to cancel any event if there are insufficient entries. Fees will be refunded for any cancelled events.

Equipment: Only USATT approved equipment will be used; Butterfly tables and white Nittaku Premium Three star 40+ Balls will be used.

Ratings: For event eligibility, the 06/15/2021 USATT web site published ratings will be used. Seeding will be based on most current ratings.
