USATT to participate any sanctioned events. Membership may be purchased with your entry. You may be asked to show proof of recent membership if your name is not on the current USATT list.

**Deadline:** 

All paid entries received by February 1<sup>st</sup> will be guaranteed participation. Entries received after the deadline may be accepted on a space-available basis. Cancellation will only be refunded if notification is given before September 8<sup>th</sup>

Check-in:

Players should check-in as early as possible and should arrive **NO LATER** than 30 minutes prior to the starting time for their earliest event. (Note: The venue opens at 8:00am).

#### **Format:**

- All Singles events are round robin for the first round. Subsequent rounds will be single elimination.
- Top 2 players from each group in the first round will advance to the next round. In Doubles events only the top team will advance to next round.
- Non rated players are not allowed to advance in rating events unless players have an established USATT league rating.
- All matches are 11 points best of 5 games, except for the final match of Open Singles, which will be best of 7 games if asked.
- USATT rules and regulations will be enforced.
- Depends on the number players we may setup 4 seeds for Open Singles and U2350

•	Maximum rating for U-3000 Doubles is 1950. Maximum rating for U-3400 is 2100. Maximum rating for U-3800 is 2250.					
Event:	Player may be removed from an event at any time should the Tournament Committee decide that the player is overqualified. The Tournament Committee also reserves the right to cancel any even if there are insufficient entries. Fees will be refunded for any cancelled events.					
Equipment:	Only USATT approved equipment will be used; Butterfly tables and white Nittaku Premium Three star 40+ Balls will be used.					
Ratings:	For event eligibility, the 01/10/2024 USATT web site published ratings will be used. Seeding be based on most current ratings.
