**Deadline:** All paid entries received by April 25<sup>th</sup> will be guaranteed participation. Entries received after the

deadline may be accepted on a space-available basis. Cancellation will only be refunded if

notification is given before April 23<sup>rd</sup>

**Check-in:** Players should check-in as early as possible and should arrive **NO LATER** than 30 minutes prior

to the starting time for their earliest event. (Note: The venue opens at 8:00am).

#### **Format:**

- All events (Singles and Doubles) are round robin for the first round. Subsequent rounds will be single elimination.
- Top 2 players from each group in the first round will advance to the next round in Singles events. Only the top pair In Doubles events will advance to the next round.
- Non rated players are not allowed to advance in rating events unless players have an established USATT league rating.
- All matches are 11 points best of 5 games, except for the final match of Open Singles, which will be best of 7 games if asked.
- USATT rules and regulations will be enforced.
- Depends on the number of players we may have 4 seeds for Open Singles and U2350
