DEADLINE: Wednesday, May 10th, 2017. No entries will be accepted after this date unless approved by the tournament committee. **A \$15 late fee will be applied to all entries after May 10th, 2017.** All entries are responsible for full payment if not withdrawn by the above deadline.

PLEASE REGISTER EARLY [36 entries max]

Entries may be rejected if space does not permit. If the event fills up prior to the deadline, entries will automatically be put on a waitlist for the event. You will be notified if you are placed on the waitlist. You will be contacted if a spot becomes available.

EQUIPMENT: Only USATT approved equipment will be used. 6 professional quality tournament tables with 1" matte tops (3 blue / 3 green), Tournament ball will be **WHITE** Nittaku 3 star premium 40+. Wood floors, gym lighting, and high ceilings. ***NO WHITE SHIRTS / NO WHITE SHORTS.**

FORMAT: GIANT ROUND ROBIN. (36 players max).

There will be a preliminary round with 12 round robin groups of 3 players. Matches will be best 3 out of 5 games to 11 points. The player with the best record from every group will advance to Division A. The players with the 2nd best record will advance to Division B, and the 3rd best will advance to Division C. There will be 2 round robin groups in every Division. The top player from each round robin group will advance to single elimination for the finals.

Racquet must be light red on one side and black on the other. Footwear must be a tennis shoe worn during play except with the permission of the referee.

USATT RATINGS: Ratings for all events will be those used as posted on the Friday May 12th, 2017 on the USATT website update. There is a difference in time between receiving first entry forms and the actual event. To account for this occurrence MINOR latitude may be provided at the tournament director's discretion.

DEFAULT POLICY: Players not checked in before the starting time of the event may be defaulted from the event.

REFUND POLICY: Players may receive a full refund if notice is given before the entry deadline. No refund will be made after the deadline unless requested by email or phone and approved by tournament committee. All entries are responsible for full entry fees if not withdrawn by the entry deadline.
