**ELIGIBILITY/RATING:** All participants must have a USATT rating. The latest ratings as of April 3 will be used for qualifications. The most recent rating will be used for seeding.

**FORMAT:** All rating events start with a round robin of 3 to 4 players. 2 Teams may advance from each round robin, followed by a single elimination playoff

**OFFICIAL EQUIPMENT:** Nittaku Premium 3 star plastic balls. 15 Butterfly tables and nets. Blue floor mat on all courts.

**RULES:** All USATT regulations, including equipment, conduct, dress, and language apply. Please DO NOT wear white clothing because the ball is white. Players may not enter 2 events with identical starting times. All matches are 11 pt. games, best 3 out of 5 games. 2 minute warm-up rule before match will apply. Each player is allowed a 1 minute time-out per match. Players must register at least 30 minutes before starting time. All decisions by the tournament referee & committee are final. Events may be cancelled combined if needed. Fees will be refunded if cancelled.
