ELIGIBILITY/RATING: All participants must have a USATT rating. The latest ratings as of Feb 5 will be used for qualifications. The most recent rating will be used for seeding.

FORMAT: All rating events start with a round robin of 3 to 4 players. 2 Teams may advance from each round robin, followed by a single elimination playoff

OFFICIAL EQUIPMENT: Nittaku Premium 3 star plastic balls. 15 Butterfly tables and Butterfly nets. Blue floor mat on all courts.

RULES: All USATT regulations, including equipment, conduct, dress, and language apply. Please DO NOT wear white clothing because the ball is white. All matches are 11 pt. games, best 3 out of 5 games. 2 minute warm-up rule before match will apply. Each team is allowed a 1 minute time-out per match. Players must register at least 30 minutes before starting time. All decisions by the tournament committee are final. Events may be cancelled combined if needed. Fees will be refunded if cancelled.
