Competition Format Awards and Prizes

Each division will consist of ten (10) teams (based on number of team entries). **REVISED**
Teams be a minimum of three and maximum of five players.
Seeding is based on cumulative rating of the top 3 players.
Only three designated players will play in each round.

Preliminary rounds are outlined on the "Tentative Time Schedule" page of this form.

Teams will compete in a modified Swaythling Cup format, with a best 4 out of 7 singles matches in each round. All matches are 3 out of 5 games to 11 points.

The top-rated player on teams with a rating difference of 400 or more points between the highest and lowest rated players must compete in at least 20% of the matches after the preliminary round(s).
