Dates: May 3rd, 4th, and 5th, 2024

Venue: Davison Athletic Club: 2140 Fairway Dr.; Davison MI 48423 (810) 653-9602. Throughout the Tournament food and drink will be available for purchase at the TIEBREKER Lounge (on-site)

Directions: **From the North** I-75 S toward Flint, Take exit 125 onto I-475, Take exit 6 toward Port Huron onto I-69 E, Take exit 145 toward M-15/Davison/Clarkston, Turn right onto S State Rd (M-15), Turn right onto Lippincott Blvd., Turn left onto Fairway Dr. **From the South** I-75 N, Take exit 91 to M-15 N, Right onto M-15, Turn left onto Lippincott, Turn left onto Fairway Dr.

USATT Sanction: This is a 4-Star, USATT sanctioned tournament. Mandatory USATT membership or tournament pass may be purchased with entry.

Basic Membership is \$25/year and a Pro Membership is \$75/year. Adult tournament passes are \$50 and Junior Tournament passes are \$20.

Equipment: Only USATT approved equipment may be used. **TABLES:** Donic and Butterfly. **BALL:** Nittaku Nexcel 3-Star 40+ orange plastic ball, provided complimentary by Paddle Palace.

Rules: Rules of the USATT will govern play. Decisions of the Tournament Committee are final. No orange shirts allowed.

Defaults: Event time is event default time.

Ratings: Rating posted on USATT on **Monday, April 22nd, 2024** will be used for eligibility. Players must be rated under 2300 to play in U3800 Doubles and under 1700 to play in U2600 Doubles.

Unrated Players: Unrated players can not advance in rated events.

Format: Singles events may be a round robin(s) followed by single elimination or a round robin depending on the number of entries. Doubles will be single elimination. All matches will be 3 out of 5 to 11 points. USATT requires 6 players for Singles Events. Single events with fewer than 5 players or 4 teams for doubles will be cancelled. The committee reserves the right to adjust format and prize money based on number of entries received.

Age Limits: Junior ages are determined as of **April 22nd, 2024**. Senior ages are determined as of **December 31st, 2024**.

Eligibility: Entrants must be 1.) Michigan residents for three months prior to the tournament or 2.) active military personnel stationed in Michigan or 3.) a full-time student going to school in Michigan.

USATT SAFE SPORT PROTOCOL FOR USATT SANCTIONED TOURNAMENTS



I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.
