All USATT rules and regulations apply including USATT dress code (no white shirts or shorts). Only USATT approved equipment may be used. Tournament officials reserve the right to modify events and group assignments, as necessary. No prizes awarded for defaults, no shows, or splits.

ENTRY DEADLINE: Entries must be received with payment by **10:00 PM, Thursday, February 8, 2018**. No phone entries accepted. Space is limited so *enter early!!!* ***Emailed copies of registration with Paypal payment will be accepted. Email address is indytabletennis@sbcglobal.net***

FORMAT: Matches are best 3 of 5 games to 11 points. Groups of 8 players seeded by rating. Each player will play 7 matches.

Other info: Start time is Eastern Time. Club will open at 8:30 AM for warm-up. Unrated players must show up 20 mins prior to start time and may not place in their event, exception being the Over 1600 round robin group. Unrated players will be placed in the Under 1800 round robin group unless a rating estimate (for seeding purposes only) is provided by a USATT certified coach or official. All played matches will count toward an unrated player's official USATT rating which will be provided online when USATT posts tournament results. Default time is start time. Snacks and drinks are available on site for purchase. Directions are available on our website.
