Do not enter 2 events with same starting time. USATT approved tiebreaking procedures will be used. No white shirts, shorts, or skirts.

• Proof of Membership: Must show USATT proof of membership for events 1-10. Memberships and renewals sold at the event. All players must either be current members or purchase a tournament pass for \$20. Membership fees: Adults \$75; Juniors/College \$45.
