**Eligibility:** Open to all USATT members and non-members.

### Format

**Teams:** 2 singles 1 doubles mandatory, and if either of the teams has not won 3 matches then the reverse singles will be played. Both reverse singles can be played at the same time; however, if a team wins tie in 4th match, if started, the 5<sup>th</sup> match must be completed and will be counted towards rating. Ratings of top two players will be used for group seeding. **Tie Format:** 1. A vs X --- 2. B vs Y --- 3. Doubles --- 4. A vs Y --- 5. B vs X

**3rd Player Rules:** Third player can be used as an alternate player. The top 2 player's rating will be used to determine the draw. The top player must play at least 3 ties 11 points, best of 3 of 5

**Rating:** Current rating from OmniPong or estimated will be used for seeding and eligibility.

**Equipment:** Only ITTF and USATT approved equipment will be allowed. Donic and Butterfly tables will be used for the tournament. 40mm WHITE Butterfly R40 balls will be used

**Venue info:** Hardwood flooring, fluorescent lighting, improved spectator seating.

**Registration:** Players must register and check in at least 30 minutes before each event starts.
