UNRATED PLAYERS: Unrated players will not be allowed to advance out of the RR in rated events. Tournament committee will be the final authority.

TOURNAMENT ELIGIBILITY & RULES: This tournament is opened to all skill levels. USATT Membership may be purchased **optionally** with tournament registration. Tournament Passes of \$20 ea. may be purchased. All USATT rules and regulations apply (clothing must **not** be white).
