**Fees:** \$20 per event. \$25 for U-2500. There is no registration or administration fee.

**Deadline:** Form and Fee must be post marked or received by **Jun 6<sup>th</sup>, 2026**. Late entries will be accepted at the tournament committee's discretion, with a late fee of **\$10.00**.
