Giant RR Format

Players will be seeded #1 through #56. Each division will consist of 8 players. Seed #1 through #8 will belong to Division A, #9 through #16 Division B, #17 through #24 Division C, and so on. All players within each Division will play each other in this giant round-robin. Unrated players will be given estimated ratings for seeding purposes and will not be awarded prizes except in Event #1 Division A.

(Tournament Committee has the right to change the number of players within each Division and/or change the number of Divisions based on the number of entries.)

Teams Format

Teams may consist of 2 or 3 players. Teams will be seeded based on the top two players of a team and will be placed in Groups of 6 per Division. Preliminary round at 9 am format:

One up, One down – for example:

One up (for Division B) Division B plays Division A, winner remains in Division A, loser continues to play One Down preliminaries.

One down (for Division B) – Division B plays Division C, winner stays at Division B

One down may be played first or vice-versa.

After the Divisions are finalized, a Giant RR will be played among the teams within the Division.

A team match is played with two players on each team and will be best of five individual matches, A v. X, B v. Y, Doubles, A v. Y, and B v. X. An individual match will be best of 5 games. (Any team member can play in the doubles match. No substitution on the singles matches during a team match. Unrated players will be given estimated ratings for seeding purposes and are eligible for prizes.)

(Tournament Committee has the right to change the number of teams within each Division and/or change the number of Divisions based on the number of team entries.)
