#### **Specific Tournament Information**

ENTRY DEADLINE: All entries must be received no later than August 12<sup>th</sup>, 2017 at 5:00 pm. Late entries may be accepted only at the discretion of the Tournament Director.

**FORMAT FOR DIFFERENT ROUNDS**: Round robin (RR) groups will be formed in all first round events. A secondary round (if applicable) will be either RR format or an elimination format. The choice of second round format will be made at the sole discretion of the Tournament Director.

PLAY FORMAT: Each time your 2-person team plays another 2-person team, your team will play a minimum of two singles matches and one doubles match, and may play a maximum of four singles matches and one doubles match. Specifically, the first two matches will be singles matches played SIMULTANEOUSLY on two tables and the third match will be a doubles match. If one team wins ALL of the first 3 matches, then they win and play is over. Otherwise, play continues with the FOURTH match (if necessary). At the end of the fourth match, if one team has won 3 out of the 4 matches, then that team wins and play is over. Otherwise, play continues with the FIFTH and final match (if necessary). Once a team has won 3 matches, play is over and they do NOT play any additional matches that are not needed. If players play unneeded matches after one team has won 3 matches, then the unneeded match(es) WILL NOT count for team results and will NOT be included in results that are submitted for USATT ratings. The Tournament Director reserves the right to require that the fourth and fifth matches be played simultaneously, if deemed necessary to expedite completion of a round. In that case, the Tournament Referee will determine whether or not both fourth and fifth matches are submitted to USATT for ratings.

First round play format will be round robin – so, as an example, groups of four teams might compete against one another in a round robin format with only the top team in a group advancing to a next round. Subsequent rounds (after the first round) will be either round robin or elimination format, as determined by the Tournament Director. If a team is one of four teams in a round robin group, each player on the team will play a minimum of three (3) singles matches and three (3) doubles matches in that round robin group, and may play a maximum of six (6) singles matches and three (3) doubles matches in the unlikely event that all team match-ups require 5 matches to determine a winning team.

**EVENT LIMITATIONS**: Rating restrictions may apply depending upon the event. It is the player's responsibility to manage their time and to be available for their matches at their designated tables when their match is called. Players not present at the table for a match may be defaulted (see no-show policy). Players may **not** register for events that start at or around the same time. For this tournament, players may enter one Saturday event and one Sunday event, but may not enter two events on one day because the events start around the same time.

UNRATED PLAYERS: Unrated players on a team may enter rating events if an estimated rating is known or can be determined - BUT.... their team may NOT advance into a second round group or be eligible for prize money or awards – only rated players may advance into a second round or be eligible for prize money or awards in rating events. Unrated players WILL get credit for matches won in terms of USATT rating point accrual. Unrated players (or teams with an unrated player) may be seeded in the draw at the sole discretion of the Tournament Director, and by the means/mechanism selected by the Tournament Director, in his sole discretion. By entering this tournament, players agree to and understand this provision.

Players MUST pre-register with a partner for all doubles or teams events. Triangle Badminton & Table Tennis may be able to help locate other players looking for partners, but will not be held responsible for finding a Doubles or Teams partner. Triangle Table Tennis cannot be responsible for the failure of any selected Doubles or Teams Partner to participate. It is the responsibility of the player to contact his/her doubles/teams partner about participating in (and paying for) the event.

#### **General Tournament Information**

**EVENT ENTRY FEES:** See registration form for fees, which vary by event.

#### **Registration Policy:**

All registrations must be properly and completely submitted. Please read the registration details carefully for each event. Your registration will be considered incomplete and will not be processed if any of the following is missing:

- A legible and fully-completed entry form
- > Completed waivers, including printed names and signatures for ALL waivers
- > Payment in full for ALL registered events, plus USATT membership or renewal fee (if needed), plus late fee (if applicable)
- A current USATT membership number or membership registration form

Full payment & fully completed entry forms are required to process an entry.

#### **Registration Payments:**

Full payment must be made at the time of registration. Accounts will be charged a \$25 fee for returned checks. Participants with declined payment will be withdrawn from the tournament.

There are multiple ways to register for this tournament. Please either:

- Complete a printed entry form, sign the waivers, and pay at the front desk by cash, check, or credit card.
- Complete the entry on-line at <a href="Omnipong.com">Omnipong.com</a>, or
- Complete a printed entry form, sign the waivers, and mail it to Triangle Badminton and Table Tennis, 2900 Perimeter Park Drive, Suite 200, Morrisville NC 27560 with a personal check (or cashiers/registered/bank check) made payable in US dollars to Triangle Badminton and Table Tennis.

**Prizes and Tax Information:** Prizes may include cash, account credit, pro shop merchandise, and/or medals. All cash prizes are in the form of checks. Players must complete Form W-9 and provide taxpayer ID (e.g., social security number) to receive prizes with monetary values. If a winner cannot fill out a W-9 form due to being a foreign national and not having a US tax ID number, then they must accurately complete a W-8BEN tax form. The prize winnings of players required to fill out the W-8BEN tax form are subject to 30% tax withholding and the prize winnings will be withheld until such time that the tournament administrators have time to process the appropriate prize amounts. Foreign national players will need to provide a valid current address to receive their taxadjusted prizes by mail.

#### **Event Limitations:**

This tournament has a limited number of players or teams allowed for each event. Complete entries with payment are processed in the order received. Once an event is full (based on a target number set at the discretion of the Tournament Director), that event will be closed and no further entries accepted. Entering early will give you a better chance of getting into an event before it is full.

#### Waitlists:

If an event is full at the time you register, then you will be automatically put on that event's waitlist. You will be informed if you are waitlisted. You will be notified if a spot becomes available. If a spot does not become available or you request to be removed from the waitlist, the registration fees for the waitlisted event will be refunded to you.

#### **Refund Policy:**

- ➤ ALL entry fees paid are NON-REFUNDABLE as of Saturday August 7<sup>th</sup>, 2021.
- > Events may be cancelled for insufficient entries, or other reasons, at the discretion of the Tournament Director.
- If an event is cancelled by Triangle Badminton and Table Tennis, or the Tournament Director, <u>for any reason</u>, then entry fees will be refunded. Refunds may take up to four weeks.
- Withdrawals & Refunds: Entry fees which are refundable (i.e., prior to seven days <u>before</u> the tournament), will be refunded ONLY as account credit. In order to claim this, a <u>written withdrawal request</u> MUST be submitted by the player for Triangle Badminton and Table Tennis to consider a refund. Please include your name, phone number, and the events you wish to be withdrawn from. All entry fees are NON-REFUNDABLE after 7 days prior to tournament date.
- An administrative fee of \$10 will be deducted from all refunds.

No-Show Policy: Players who are not present at match start time for any event forfeit their position and entry fees for that event.

**Dress Code:** USATT Dress Code will be enforced in all cases as determined by the Tournament Referee.

**Rules:** All USATT Regulations apply, and all participants must abide by the decisions of the tournament staff and officials. Triangle Badminton and Table Tennis Club Rules will also be enforced; violators may be asked to leave. If ejected due to violation of Club rules, the player will be defaulted automatically and no fee refunds will be issued. Players that default a match or matches for non-health related reasons may not be eligible for prizes and will also be at risk for future entry into Triangle Badminton and Table Tennis tournaments.

**Equipment:** All USATT Regulations Apply. Only USATT/ITTF approved equipment will be used. Tables will be Butterfly Centrefold 25 blue color with Butterfly Europa net sets. Floors are all covered with Gerflor (Taraflex) flooring. Balls will be Butterfly 3-star white R40+ premium competition poly balls.

**USATT Membership**: Players must have a currently active USATT membership to play in USATT sanctioned events. Players without a currently active membership at the time of registration must include their USATT registration or renewal fees along with their tournament event fees when submitting payment. Please see USATT membership page for more details on membership options and rates.

#### **Required USATT Statements:**

- 1) Events with insufficient entries may be cancelled at the discretion of Triangle Badminton and Table Tennis. Fees managed as outlined in the refund policy.
- 2) If a rating event is cancelled, player will automatically be placed in the next highest rating event (only if applicable based on tournament format). Not applicable in teams tournaments.
- 3) The current USATT rating system will be used for the purposes of conducting all draws with the possible exception of hardbat events, if offered. For players that do not have a USATT rating, an estimated USATT rating will be assigned based upon a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible.
