Tournament Format: This tournament will offer Three events and please see details below. All USATT regulations and rules apply. All final rules are subject to OCTTA.

Entry Fees is \$120/Team, COLLEGES and JUNIOR Teams Fees is \$100/Team.

A Division: Team Rating: Under 6050/Team , Maximum Team allowed: 40. **Play date: 01/05/2019.**

1st place: \$1000/Team; 2nd place: \$500/Team; 3rd place and 4th place: \$300/Team.

Each team will consist of three or maximum four players, where the combined rating for the three players must be 6050 or less. **Player with lower than 1550 rating will enter event as 1550 rated player.**

B Division Team Rating: Under 5350/Team; Maximum Team Allowed: 40. **Play date: 01/06/2019.**

1 st place: \$1000/Team; 2nd place: \$500/Team; 3rd place and 4th place: \$300/Team .

Each team will consist of three or maximum four players, where the combined rating for the three players must be 5350 or less. **Player must have USATT rating below 2050 to enter this event.** Teams will be seeded into preliminary round robins of 3 to 4 teams. The top two teams from each Round Robin will advance into a single elimination championship.

C Division : Team Rating: Under 4350/Team; Maximum Team Allowed: 40. **Play date: 01/05/2019.**

1 st place: \$1000/Team; 2nd place: \$500/Team; 3rd place and 4th place: \$300/Team .

Each team will consist of three or maximum four players, where the combined rating for the three players must be 5350 or less. **Player must have USATT rating below 1650 to enter this event.** C DIVISION MUST HAVE 20 TEAMS TO GET FULL PRIZES MONEY, OTHERWISE 25% FEES GO TO OCTTA, 75% FEES TO PRIZES (FIRST 60%, SECOND 20%, THIRD AND FOURTH 10%).

Order of Play: Each Team match only allowed 3 players to play and no one can play more than two matches. When the team match is called, each team will report to the Control Desk where one team will be designated the A/B/C team and the other X/Y/Z. The first three matches are singles matches, in which each player from each team must play once, in any order chosen by each team. The first team to win three individual matches wins the team match. The fourth match, if necessary, will be a doubles match. The fifth match, if necessary, will be a one game singles match; whoever scores 5 points first will win the match, with no deuce allowed. Each team can choose any player for the fourth match. The player for the fifth match, if necessary, cannot be the player for the fourth match.

Ratings and Deadline: Your official USATT rating and Deadline for this tournament will be the one listed on the USATT website as of **DECEMBER 15, 2019. NCTTA rating will be accepted to encourage COLLEGES to participation.**
