Pacific Region States: Alaska, California, Hawaii, Idaho, Montana, Nevada, Oregon, Washington, and Wyoming. For Regional Championships Round Robin System will be used. First Place in each group qualify to Championship Division Single Elimination. Top 3 Teams in Championship Division will qualify for National Club Team Championship. Olympic Team Championship will be used (ABC vs XYZ).

**Entries:** All entries will be through [www.omnipong.com](http://www.omnipong.com) - All Payments to be received by 5/18/2023. All players must show proof of membership with USATT at the time of registration. Players not holding a current USATT membership must include their USATT registration or renewal fees along with their tournament event fees when submitting payment.

**Ratings:** May 1<sup>st</sup>, 2023, Ratings will be used for eligibility.

**Rules:** All USATT regulations apply; Only USATT approved equipment; USATT dress code will be enforced. Players cannot enter two events starting at the same time. All winners will receive free entries at 2023 US Nationals for the respective event. All participants must be USATT Basic Member.

## USATT SAFE SPORT PROTOCOL FOR USATT SANCTIONED TOURNAMENTS

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.
