ENTRY DEADLINE: All mail & online entry must be received by February 16. You can register via text or email & can pay on the day of the tournament. No refunds after the deadline or on the day of the tournament.

ELIGIBILITY DOUBLES RATING: All participants must be current USATT members. The latest ratings as of February 11 will be used for qualifications. The most recent rating will be used for seeding.

- Players MUST be rated under 2600 to participate in the U4700 Doubles
- Players MUST be rated under 2500 to participate in U4200 Doubles
- Players MUST be rated under 2400 to participate in 3800 Doubles.
- Players MUST be rated under 2200 to participate in 3200 Doubles.
- Players MUST be rated under 1800 to participate in 2800 Doubles.
- Players MUST be rated under 1600 to participate in 2400 Doubles.
- Players MUST be rated under 1400 to participate in 2000 Doubles.

FORMAT: All rating events start with a round robin of 3 to 4 players. 2 players may advance from each group, followed by a single elimination playoff.

OFFICIAL EQUIPMENT: Nitaku 3 star. 15 Butterfly tables and nets. Red floor mat on all courts.

RULES:

All USATT regulations, including equipment, conduct, dress, and language apply. Please DO NOT wear white clothing because the ball is white. Players may not enter 2 events with identical starting times. All matches are 11 pt. games, best 3 out of 5 games. The 2-minute warm-up rule before the match will apply. Each player is allowed a 1-minute time-out per match. Players must register at least 30 minutes before starting time. All decisions by the tournament referee & committee are final. Events may be canceled combined if needed. Fees will be refunded if canceled.

USATT SAFE SPORT PROTOCOL FOR USATT SANCTIONED TOURNAMENTS

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport. PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain **Positions of Authority** must complete SafeSport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). The list of Positions of Authority requiring **Full Safe Sport Compliance** is set out in USATT's Safe Sport Policy and the Athlete Safety Section of the USATT Website: <https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport>.

USATT COACHING POLICY

All persons who are engaged in **coaching activities** at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, **except parents or legal guardians coaching their own children**, must be **Fully Safe Sport Compliant**, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, **ALL Adult Participants** (participants over the age of 18) **who have regular contact with or authority over minor aged athletes** must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").

CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT

USATT is pleased to assist USATT Members in the process of becoming SafeSport Trained and/or Fully Safe Sport Compliant. Please contact USATT at Admin@usatt.org for more information and guidance in this process.

MANDATORY REPORTING

There are certain circumstances where **reporting a potential Safe Sport violation is mandatory**. These circumstances include: (i) child abuse; (ii) sexual misconduct; (iii) emotional and physical misconduct; (iv) criminal charges and/or dispositions involving sexual misconduct or misconduct involving minors; (v) any abuse of the Safe Sport process. **Child abuse must be immediately reported to local law enforcement**.
