ENTRANT REQUIREMENTS: All players entering the tournament needs to be born after January 1st 2000. We will use the current USATT rating system to conduct all draws. If you do not have a USATT rating we will use Rating central +700. Unrated players will be drawn with a rating of 0.

ENTRY DEADLINE: All entries must be received by Thu. **Jan. 25th, 2017**. Late entries, phone entries and walk-ins will only be accepted if space is available and at the director's discretion.

REGULATIONS: All USATT regulations will apply but Tournament Directors has discretion in special situations. USATT approved equipment are to be used. All players need to play in shorts and shorts/skirts and short sleeved shirts. U-15 years old is considered born after January 1st 2003, U-12 years old is considered born after January 1st 2006, U-10 years old is considered born after January 1st 2008.

ENTRY: Entrants may enter multiple events but only one event per starting time. Events with insufficient entries may be combined with the next highest age category or combined gender if possible. CONDUCT: Follow the sequence of play on the score sheet so you will be aware when you are next up. Please keep your warm-ups limited to two minutes and write down the scores after each game. Following the completion of a RR or a SE match, bring the completed score sheet with the clip board, and balls and pencils used to the control desk.

FOOD/PARKING: Paddle Palace Club is located in downtown Tigard on Main Street, 20 minutes from downtown Portland. The venue location offers several restaurants within walking distance and free street parking, in addition to the venue's 35-space parking lot.

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
