<u>Professional facility</u> - 22' ceiling, Enlio rubber floor, white Butterfly **R40+** balls, blue Butterfly Europa tables, lounge, breakroom, lockers

<u>Format</u> - Round robin events with 4 or more players per group with 2 advancing from each group to single elimination (SE). All matches best 3 out of 5, except for Open Doubles finals, which will be 4 out of 7. We reserve the right to change formats as necessary.

<u>Rules</u> - All USATT regulations apply; only USATT approved equipment; USATT dress code will be enforced - no white clothing. Players cannot enter 2 events with the same starting time. Hardbats must be all wood, with rubber listed on Harbat.com or equivalent.

* The highest player on the 3200 Doubles must be 2000 or less. ** The highest player on the 3800 Doubles must be 2300 or less. NOTE: At the discretion of the referee, any unrated player whose level of play, combined with their partner's rating, exceeds the rating limit for the 3200 or 3800 Doubles will be disqualified.

<u>Payments</u> - Withdrawals through Monday, August 15 will receive a refund. No refunds after Agust 15. All payments must be received by midnight August 15. Late entries may be accepted until August 18 with a \$5 late fee based on availability. No phone entries. **All entries must be paid prior to participation.**

<u>Food/Hotel</u> - The playing venue is near several fast food and other restaurants; Courtyard by Marriott Columbus West (614) 771-8999.

<u>Ratings</u> - Ratings from July 15 will be used for eligibility. Updated ratings will be used for seeding. Tournament staff may modify, combine, cancel events and limit total entrants. Unrated players may advance from all events and receive prizes.
