Rules: Sanctioned as a 2-star tournament by USA Table Tennis. USATT regulations apply, including dress code, unless otherwise noted.

Equipment: Killerspin MyT10 tables, nets & 3-star 40mm+ XuShaoFa poly balls, red rubber floors. ITTF/USATT approved equipment only. All dress code must abide to ITTF/USATT policy.

Entry deadline: Nov. 18th, 2017. No Refunds after deadline.

Format: All events are round robin (3-4 players per group) followed by single elimination. All other matches are best 3 of 5, except for semifinals and final of Open, which are best 4 of 7. Unrated players will not advance out of rated round robin events unless a rating can be reasonably assigned by the Director. Unless permission is given by Director, all finals must be played. Director reserves the right to modify or cancel events, if there are insufficient entries. If so, players will be notified via email the night before the event starts. Match time is default time.

Open Singles: Players under 2000 who enter at least two other events may enter the Open at half price. Players over the cut-off for the highest rating event (and possibly other seeded players) will be seeded out of preliminaries. There must be at least 12 players to hold Open Singles.

Rating: ratings one week prior to the tournament day will be used for event eligibility.

Membership: Proof of USATT membership is required. Memberships may be purchased at the tournament.

Adult membership is \$75/year or \$210/3 years. Junior membership is \$45/year (17 yrs. or younger) or \$125/3 years (14 yrs. or younger). Tournament pass is available for \$20.
