Fall 2023 Classic GIANT ROUND ROBIN Tournament

LONGMONT

This Saturday's event is an U1850 GIANT ROUND ROBIN.

The Morning Session is used to establish the afternoon playing groups, to sort players by skill level during actual play, independent of existing USATT ratings.

Morning Session:

8 RR groups of 5 players each = 4 matches per player. Within each group of 5, top finisher becomes (A) division, 2nd place becomes (B) division, etc. for the Afternoon Session. All players advance to Afternoon Session.

Afternoon Session:

Each Division (A, B, C, D) will have (8) players. Each division of (8) players is split into 2 RR groups of (4) players each: (A1, A2, B1, B2, etc.) = 3 matches per player.

The (2) top finishers from each group of (4) (within each division) advance to a 4-player single elimination playoff => semi-finals and finals, resulting in a champion and runner-up for each division.

Everyone will get seven (7+) matches (IF FILLED).

Trophies/Medals will be awarded to each level A – B – C – D – E → 1st, 2nd place

Unrated players in singles events with defined rating limits will get credit for matches won in the first round in terms of USATT rating point accrual. Unrated players may be seeded in the draw at the sole discretion of the Tournament Director, and by the means/mechanism selected by the Tournament Director, in his/her sole discretion.

**** This does not apply to AGE GROUP EVENTS.**

NOVICE PLAYERS: Can be defined as a player with no USATT RATING, BELOW A CERTAIN AGE, BEGINNER LEVEL OBSERVABLE TABLE TENNIS ABILITIES or a COMBINATION OF THESE FACTORS. The Tournament Director reserves the right to move a player **IN/OUT** of a **NOVICE** event based on the factors listed above.

DEFAULTS - SPLITS - DUMPS: No prizes will be awarded or advancement of players that **splits, dumps, defaults, or no-shows**.

Default time is the start time of the event. If you participate in any of these activities/actions, you will not be allowed to play in the following NorthSide TTC Tournament.

EVENT ENTRY FEES: See Event Table (ABOVE) for fees, which vary by event.

ONLINE ENTRY/PAYMENT DEADLINE: All ONLINE entries/payment must be received no later than THE MONDAY PRIOR TO THE TOURNAMENT DATE by 5:00pm. Late entries may be accepted only at the discretion of the Tournament Director. Please contact Peter Christofolo with any questions (303) 601- 3415.

Registration Policy:

All registrations must be properly and completely submitted. Please read the registration details carefully for each event. Your registration will be considered incomplete and will not be processed if any of the following is missing:

- A legible and fully completed entry form.
- Completed waivers, including printed names and signatures for ALL waivers.
- Payment in full for ALL registered events, plus USATT membership or renewal fee (if needed), plus late fee (if applicable)
- A current USATT membership number or membership registration form.
- Full payment & fully completed entry forms are required to process an entry.
- ALL EVENTS ENTRIES WILL BE SUBJECT TO CANCELLATION IF FULL PAYMENT IS NOT MADE ON OR BEFORE THE MONDAY PRIOR TO THE TOURNAMENT DATE.

NOTE: Accounts will be charged a \$25 fee for returned checks. Participants with declined payment will be withdrawn from the tournament.

Refund Policy:

- ALL entry fees paid are **NON-REFUNDABLE** the Monday prior to the start of the tournament. For instance, if the tournament starts on a Saturday, then entry fees are non-refundable starting on the previous Monday. In this case, refunds would have to be submitted by the previous Sunday or before. To claim this, a written/verbal withdrawal request MUST be submitted by the player for **Denver NorthSide Table Tennis** to consider a refund. Please include our name, phone number, and the events you wish to be withdrawn from.
- Events **may** be cancelled for insufficient entries, or other reasons, at the discretion of the Tournament Director. If an event is cancelled by **Denver NorthSide Table Tennis** or the Tournament Director, for any reason, then the FULL entry fees will be refunded. Refunds may take up to four weeks.
- An **Administrative Fee of \$10.00** will be deducted from all refunds.

General Information

Event Limitations:

This tournament has a limited number of players or teams allowed for each event. Complete entries with payment are processed in the order received. Once an event is full (based on a target number set at the discretion of the Tournament Director), that event will be closed, and no further entries accepted. Entering early will give you a better chance of getting into an event before it is full.

Waitlists:

If an event is FULL at the time you register, there is a waitlist available. There is no charge to be put on the wait list. You will be notified if a spot becomes available. There will be ONE ATTEMPT to contact you by **PHONE** and/or **TEXT** if a spot becomes available. If a spot **does not** become available, **I will try to notify** you by phone and/or text. You also can remove yourself from the waitlist if you wish not to be considered for a place in the tournament.

NOTE: If a player is bumped out or moved out of an event because of a rating increase she/he will move to first position on the wait list. This is also true if a player has temporary injury.

No-Show Policy:

Players who are not present at match start time for any event **forfeit their position and entry fees** for that event.

Dress Code:

USATT Dress Code will be enforced in all cases as determined by the **Tournament Referee**. Please do not wear clothing that contains any colors, or colors in a design, or reflective objects that are not approved by USATT, this includes **big designs/numbers, long pants, tank tops, sleeveless shirts, and hats**. Players/spectators wearing clothing that may reach the level of being considered offensive or distracting, they will be asked to change clothes or leave the playing area.

Note: This will include anything that contains a **WHITE** color in the design.

Rules:

All USATT Regulations apply, and all participants must abide by the decisions of the tournament staff and officials. Denver NorthSide Table Tennis Rules will also be enforced; violators may be asked to leave. If ejected due to violation of Event Center rules, the player will be defaulted automatically, and no fee refunds will be issued.

We are here to support our players. Distraction will not be tolerated. The tournament director has the final say in these matters.

Equipment:

All USATT Regulations Apply. Only USATT/ITTF approved equipment will be used. Tables will be Joola 3000SC blue color with Joola WM net sets. The floor is all covered with gymnasium wood flooring. Balls will be **Nittaku** white 40+ premium competition poly balls.

USATT Ratings:

Ratings as posted on USATT website approximately FOUR (4) weeks before the tournament are used for USATT-rated events.

USATT Membership:

Players must have a currently active USATT membership to play in USATT sanctioned events. Players without a currently active membership at the time of registration must include their USATT registration or renewal fees along with their tournament event fees when submitting payment. Please see the USATT membership page for more details on membership options and rates.

Required USATT Statements:

- Events with insufficient entries may be cancelled at the discretion of Denver Northside Table Tennis. Fees managed as outlined in the refund policy.
- If a rating event is cancelled, the player will automatically be placed in the next highest rating event (only if applicable based on tournament format). Not applicable in teams' tournaments.
- The current USATT rating system will be used for the purposes of conducting all draws. For players that do not have a USATT rating, an estimated USATT rating will be assigned based upon a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible.
- All entrant agrees to abide by USATT regulations and decisions of the tournament officials.

Event Cancellation/Adjustments:

Events with insufficient number of entries or facility challenges can be cancelled/combined/adjusted at the discretion of the Tournament Director.

I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
