



2026 ITTF Americas Cup – Entry for US Players Qualification

Dates – January 28-29, 2026

Main Draw Dates – January 30 – February 1, 2026 (Qualifier for 2026 ITTF World Cup)

Location: 888 Table Tennis Center, 888 Hinckley Rd, Burlingame, CA

Eligibility: Only Players that are eligible to represent US in **World Events** are allowed to enter this event. For entering in the event, you must be registered under USA in the database – to register in the database. Please follow the steps in Page 2.

If player is already in database under USA, that does not mean they are eligible to represent USA in Panamerican Championship/Cup/Games, Worlds or Olympic Games. If you were born outside U.S. or represented another country, there is a wait period of 9 years for adults to represent U.S. after being added to ITTF database under USA and after player asked USATT to start eligibility change process.

Entry Deadline for Participants Already Registered in ITTF/ WTT System: January 5, 2026

Accreditation Fee: \$300 – Qualification Draw -non-refundable if withdrawing after Deadline

System of Play

- **Qualification Draw (January 28-29, 2026)** – Open Event, directly single elimination. Semifinalist of Qualification Draw make it to Main Draw
- **Main Draw (January 30 – February 1, 2026)** - Best of 7

Steps to Enter

1. Pay the entry request fee to admin@usatt.org PayPal. Payment amounts are listed in this [document](#)

This is a different fee than the entry fee which you will pay in Omnipong when tournament is in USA; or directly to international organizer when tournament is outside of the USA.

2. For international tournaments, a player can only be entered by USATT and the same player has to be registered under USA in WTT/ITTF database. If player has never played WTT or ITTF event, that means they have to be added to the database. There is a one time flat fee of \$100 to be processed. Payment needs to be completed to PayPal email admin@usatt.org

The process to get into WTT database is below:

a) Please email a player's picture of the passport and home address in USA to jasna@usatt.org
