Entry Fee: 225 US\$ per person (players, coaches, ACC, medical, delegates, parent coaches) - all people that want to enter field of play + \$5 Payment Processing Fee

SINGLES

U13, U17: August 6-7

U11, U15, U19: August 8-9

MIXED DOUBLES

U15, U19 – August 8-9

The entry fee (accreditation) is mandatory for all players and other participants entered for the Event and excludes accommodation, meals, and transportation.

This is a non-hospitality event and as such hotel accommodation is not offered. There is a discounted hotel available at Ruby River Hotel (walking distance) at \$109/night:

GENERAL: By entering the event all acknowledge and agree that they shall comply with the WTT rules, regulations, policies and additional requirements and procedures as issued by WTT.

1. Pay the entry request fee to admin@usatt.org PayPal. Payment amounts are listed in document below

This is a different fee than participation fee which you will pay in omnipong when tournament is in USA; or directly to international organizer when tournament is outside of the USA.

2. For international tournaments, a player can only be entered by USATT and the same player has to be registered under USA in WTT database. If player has never played WTT tournament, that means they have to be added to the database. There is a one time flat fee of \$100 to be processed. Payment needs to be completed to PayPal email admin@usatt.org

The process to get into WTT database is below:

a) Please email a player's picture of the passport and home address in USA to jasna@usatt.org

b) You will also need to complete one participation form:

- Country Code is USA

- ID leave blank as you do not have one yet

- Page 10 leave blank

- Your and child's signatures need to be real (signature can not be computer generated and it can not be typed in a different font, it is required real signature which can be inserted into the file)

- all 18 pages need to be in one pdf file and max 2MB (no zip files, please compress if the file is too large)

- if participation form is not done correctly, it will take longer time for the processing so please follow instructions

- email the file to jasna@usatt.org

c) after all info is uploaded, WTT will be able to activate player's account so the player can be entered in WTT tournaments

3. For WTT tournaments in USA, please select for youth events maximum of two singles and 1 mix doubles events and process participation payment in omnipong. Events have to be consecutive (no skipping). Once you are listed in omnipong, you will be entered in the WTT system and at that point you are obligated to pay any penalties for cancelations.

4. For WTT tournaments outside USA, you will fill out form below which is commitment that player will participate and player is obligated to pay any penalties after withdrawing from the tournament. Please note in the form which events will player play. There are max of 2 consecutive age events (no skipping) and 1 mix doubles
