Camp coaches: Head Coach: Samson Dubina, Assistant coach Chance Friend. Samson is a US National Developmental Team Coach and ITTF Level III Certified. Depending on the group size, additional coaches may be added.

Eligibility - Players must be born on or after 1/1/2008 and qualified through the Regional Hopes Qualifications held in 2020 in CA, OH, MA, NJ, and TX. The Maryland Regional Hope Qualification was unable to be played due to COVID. We will open 4 sports for boys and 4 sports for girls to the top-rated players as November 1st that would like to participate. The total number of players for participation will not exceed 48 players. Alternates based on rank order from each region will be allowed to fill-in spots for any qualifiers choose not to participate.

Participants will receive expert coaching and training by the hosting Club local coach(es) in a fun, educational, rewarding environment in which they will meet, learn, and share experiences.

Covid19- SDTTA will provide daily disinfecting, and State Covid19 restrictions will be followed.
