PLEASE READ THOROUGHLY AND PROVIDE YOUR SIGNATURE

IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin, I:

ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand the nature of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activities.

FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activities, the condition in which the Activities takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in such Activities.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activities takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I swear and affirm that I am in good physical condition and I am not aware of any previous or existing diseases or injury that would result in my being injured. I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in the 2021 US National Table Tennis Championships. I give my consent to participate in any and all emergency transportation associated with activities during the 2021 US National Table Tennis Championships, in the event I become incapacitated or otherwise not conscious to give direct consent and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.

3. Participants are not permitted to be closer than six feet to the Tournament Director's work area.
4. It is recommended that players refrain from shaking of hands after matches.
5. Participants are required to follow all rules related to usage of competition balls and care and cleaning of competition tables.
6. No food is allowed inside the competition venue.
7. In event of event cancellation due to COVID-19 restrictions being extended or introduced then refund of entry fees will be made to players.

A PLAYER MUST PAY THE FULL REGISTRATION FEE WITHIN SEVEN (7) DAYS OF SUBMITTING THE ENTRY FORM FOR THE TOURNAMENT, OR THAT PLAYER WILL BE DROPPED FROM THE TOURNAMENT REGISTRATION.

UNDER NO CIRCUMSTANCES WILL A PLAYER WHO HAS NOT PAID IN FULL BY JUNE 15, 2021, BE PERMITTED TO PLAY IN THE TOURNAMENT.

Eligibility: Entries are limited to persons holding active USATT Pro Membership through July 9, 2021 - or who have paid the Tournament Entry Fee for the US National Table Tennis Championships.

National Championships Events: U.S. Citizens-Proof of Citizenship must be submitted with the entry form.

Hardbat and Sandpaper Events: (Events 41 - 48) For All Above Events Please contact USATT Headquarters (719-866-4583) (Tina.Ren@USATT.org) regarding eligibility and rules questions.

Rules: The 2021 US National Table Tennis Championships will be conducted under the USATT Rules. All decisions by the Tournament Committee will be final and contestants upon entering agree to abide by them.

Equipment: Tables and nets: STAG. Balls: Nittaku Premium 40+ (White). Floor: For the 2021 Nationals, USATT expects that the majority of courts will be matted with competition red rubberized flooring. It is possible that some courts may not have red rubberized flooring and may be on concrete flooring. Rackets in all events are subject to random testing for volatile organic compounds (VOC's). Any glues containing VOC's will cause the racket to fail. EXCEPT FOR HARDBAT AND SANDPAPER EVENT'S, RACKETS MUST COMPLY WITH THE RED/BLACK RULE.

Clothing: The USATT Dress Code will be enforced. No white clothing will be allowed. Players must wear the assigned number or their name on the back of their shirt when competing. Names must be large and visible to spectators. It is recommended that each player come to the table with 2 distinctively different colored shirts.

Entries - Participants in the 2021 US Nationals may not enter two events that are scheduled to start at the same time.

Option to Cancel Event(s) Due to Lack of Participation - The US Nationals' Competition Manager reserves the right to cancel events and all prize money associated with that event if there are fewer than three (3) persons registered to participate in that event.

Adding or Dropping Events:

For Participants electing the Flat Fee Event Entry Structure, events may be added or dropped up to June 15, 2021. After June 15, 2021, no additional events may be added to your registration, events may only be dropped.

For Participants electing the Event Fee Pricing Structure, the participant may substitute one event already purchased for another up to June 15, 2021; such participant may also purchase (for \$80.00) and add additional event(s) up to June 15, 2021. PLEASE NOTE THAT THERE ARE NO REFUNDS FOR EVENT FEE PAY STRUCTURE for events that the participant elects to drop or from which the participant withdraws. Please see below for the full REFUND POLICY.

Age Restrictions: Players assume the responsibility of entering the appropriate age events. Players who are over/under the age limit of an event will automatically be entered in the correct age event.

Unrated Players: Unrated players are not permitted to enter rating-restricted single elimination events. Players who enter a rating-restricted event without a rating and who acquire a rating between the qualification cutoff (May 31, 2021) and the seeding (June 21, 2021) will be permitted to participate in the single elimination rating events.

Matches: All matches at the 2021 US National Table Tennis Championships will utilize 11-point game rules with the exception of Hardbat and Sandpaper events (see Hardbat and Sandpaper info). Other than the Men's and Women's Singles Championship events, which will be best of seven (11-point games) from the round of 32, all matches at the 2021 US National Table Tennis Championships will be best of five (11-point games).

Event Scheduling: Events are not guaranteed to be completed on the same day that they begin. No refunds will be given for early departure. All events will be completed by Friday (July 9, 2021) evening. Any event may be cancelled if the event contains fewer than three players. (For Event Fee Participants, the cost of an event cancelled for lack of appropriate numbers of participants will be refunded.) In the case of event conflicts, the player is responsible for notifying the Control Desk as soon as possible. In case of an inadvertent error, liability is limited to the refund of the event fee for the event(s) involved. Each event will begin on the date/time designated on the form, and it will continue at regular intervals until a champion has been determined. An entrant's signature on the tournament entry form acknowledges that the dates are acceptable for participation in the registered events regardless of any holidays, federal, state, local, religious, or foreign.

Championship Age Events: Proof of age must be readily available at the tournament.

Withdrawal/Refunds:

FOR PARTICIPANTS ELECTING THE FLAT FEE PAYMENT STRUCTURE: A \$50 processing fee will be charged to any participant who withdraws from the tournament prior to June 15, 2021. There will be NO REFUNDS given after this date except for injured players with a signed doctor's note. Please note that there is still a \$50.00 processing fee for those persons who withdraw after presenting a signed doctor's note. Withdrawal notification must be in writing at USATT Headquarters in order to receive a refund.

FOR PARTICIPANTS ELECTING THE EVENT FEE STRUCTURE: There are NO REFUNDS. However, if a participant presents a signed doctor's note and requests to withdraw from the tournament, that participant will be refunded the fees paid under the EVENT FEE PRICING structure minus a \$50.00 processing fee. Withdrawal notification must be in writing at USATT Headquarters in order to receive a refund.

PLAYING FORMATS:

Championship and Ratings Events: All events held in the 2021 US Nationals Table Tennis Championships will be **ROUND ROBIN** format. **For further information on the rules for preliminary round play AND qualification for the Main Draw and Seeding, please refer to the USATT website.**

All Championship Events: Winners from the US Nationals State Qualifying Tournaments and qualifiers from the Regional Qualifying Tournaments will be seeded into the Main Draw. All other players will be drawn into a **ROUND ROBIN** preliminary round. **For further information on the rules for preliminary round play AND qualification for the Main Draw and Seeding, please refer to the USATT website.**

RATING EVENTS 30—37: All Ratings Events will be ROUND ROBIN FORMAT. Players may enter a maximum of six (6) rating events based on their rating as of May 31, 2021. Events chosen must be within any 6-sequential order that are above his/her rating used for the 2021 US Nationals. For example, if a player's rating is 1146, he/she may participate in any or all of the following: U1400, U1600, U1800, U2000, U2200 and U2300. However, he/she may NOT participate in the U1400, U1600, U1800, U2200, U2450, and U2550 events since this covers a range of more than 6 events. Players that are over the rating limit of an event will automatically be entered in the next higher rating event. If two events with the same start time are entered, the player must decide in which event they choose to participate. Tournament Committee will choose on behalf of the player which event is to be played if the player could not be reached by phone and/or email.

Prospectus - 2021 US National Table Tennis Championships

DEFAULTS IN YOUTH EVENTS OR MEN'S AND WOMEN'S CHAMPIONSHIP EVENTS: (Events 1 - 29, 38-40)

An athlete who defaults in any Youth and/or Men's or Women's Championship Event is considered to have completely, fully and finally defaulted the opportunity for any further participation whatsoever in the 2021 US National Table Tennis Championships. However, in cases where the default is due to illness or injury, an athlete may appeal to the Referee, who may seek the guidance from the CEO of USATT, for the right to be permitted to participate in a separate Youth and/or Men's or Women's Championship Event for which the athlete has previously registered other than the Event in which the athlete defaulted. The Tournament Referee is vested with the sole authority, with the guidance of the CEO of USATT, but without opportunity for appeal, to determine whether the athlete's default was due to a verifiable injury or illness and whether the athlete should be permitted to compete in a said separate Event.

Seeding: All events will be seeded based on the USATT Rating List generated on June 21, 2021.

Open Sandpaper (Events 47 and 48): The same rules as Hardbat (see below) will apply except the equipment will be a wooden blade with a sandpaper only cover on the playing surface. These events do not count for USATT ratings points. All players must be US Citizens and proof must be submitted with the entry form. 38mm balls will be used. Quarterfinals through Final will be 3 out of 5, 21 point games; all other matches will be 2 out of 3. Hardbat Ratings will be used for eligibility and seeding.

Hardbat Events: Hardbat rules, as adopted by the USATT Classic Table Tennis Committee, will be used for all hardbat events. See www.hardbat.com for the complete list of official rules. As in all events, a question of racquet legality is the decision of the Tournament Referee. These events do not count for USATT ratings points. Both eligibility and seeding for the hardbat events will be determined by the player's hardbat rating (or USATT rating at the seeding cutoff date of June 21, 2021, if the player does not have a hardbat rating). All hardbat matches will be played to 21-point games. All matches will be the best of 3 games, except for the quarterfinals, semifinals, and final of events 41 and 42, which will be best of 5 games. Balls: Nittaku Premium 40+ (White).

TOURNAMENT INFORMATION:

Daily Check-In Hours:

Under COVID-19 protocols, it is currently expected that all registration for the 2021 US National Table Tennis Championships will be a no-touch digital experience.
