Rules/Policies/Equipment

- USATT membership or tournament pass is required for rated events (see below). Ratings cut off for event qualification is April 26, 2024. The latest rating will be used for seeding.
- All USATT regulations and rules apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows.
- Equipment will be 10 DHS tables and white Nittaku Premium 40+ balls.
- Tournament staff reserves the right to change the event formats or start times.
- Players must check-in at least 30 minutes prior to event start time. Default time is start time.
- Entries are first come/first serve. Entries and payment must be <u>received by Monday, May 13, 2024</u>. No refunds for cancellations after entry deadline.
- Late entries and walk-ins are ONLY allowed in the U-900/Recreational event & at least 30 minutes prior to start time.
- Events with insufficient entries may be cancelled with full refund given.
- Online registration is available on OmniPong.com. There is a \$10 fee for online registration and payment.

USATT SAFE SPORT PROTOCOL FOR USATT SANCTIONED TOURNAMENTS

following:
I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years. I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.
