COMPETITION FORMAT	GENERAL POLICIES	Registration and Membership
Players must check-in at least 30 minutes prior to event start time. Default time is start time.  Matches will be best 3 of 5 games. Format will be 4 person round robins with the top player/team advancing to single elimination; top two will advance in the Men's and Women's Opens. Unrated players may not move out of initial round robin in the events #2, 3 and 4. Doubles, U-900/Recreational and Junior Novice are unrated.  Participants must be residents of the State of Wisconsin, or enrolled in a Wisconsin school.	All USATT regulations apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows. USATT approved tie-breaking procedures will be used. Events may be modified at the discretion of the Tournament Committee. All decisions are final.  Entries are first come/first serve. Entries and payment must be <b>received by Monday, April 21, 2025</b> . No refunds for cancellations after entry deadline.  Late entries and walk-ins are ONLY allowed in the U-900/Recreational event & at least 30 minutes prior to start time.	All players must show proof of USATT Basic Membership. Memberships can be purchased on Omnipong. Basic \$25; Pro \$75; Adult Tournament pass \$50; Junior tournament pass \$20.  Online registration is available on Omnipong.com. There is a \$10 fee for online registration and payment.  All matches will count towards USATT Ratings except in events 5, 8 and 10.  Deadline for registration: April 21, 2025, if mailing, registration form must be received by April 21, 2025.

\*Esquire is 45 years old or older by the end of 2025.  
 \*\*Youth means born on or after 1/1/2006  
 \*\*\*Recreational is for players who are not rated or have a rating U-900.  
 Junior Novice is for youth 14 years and younger (on day of tournament) and unrated.  
 Elimination rounds may be played later as tables become available.

**USATT SAFE SPORT PROTOCOL FOR USATT SANCTIONED TOURNAMENTS**

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.
