**New Olympic Team Format will be used:**

1. BC V YZ (DOUBLES)
2. A V X
3. C V Z
4. A V Y
5. B V X

**First team to win 3 matches wins the Team Match**

**Individual Matches are 3 of 5 games to 11 points.**

\*The top-rated player on teams with a rating difference of 400 or more between the top-rated and the lowest rated must compete in at least 20% of the matches after the preliminary round.

**MAX NUMBER OF PLAYERS PER TEAM IS 4.**

**COMPETITION SCHEDULE**

**Day 1 – Saturday, August 8<sup>th</sup>, 2020 -9am-8pm. Preliminary round for placement followed by Division play.**

**Day 2 – Sunday, August 9<sup>th</sup>, 2020, 9am-4pm. Division play and finals. Expect to play in 6 to 8 team matches over 2 days.**

**PROOF OF MEMBERSHIP**

All players must show proof of membership with USATT. Membership can be renewed at the event. (\$45 for juniors; \$45 for college students with ID; \$75 for Adults). You may also purchase a tournament pass for \$20. Players must show proof of membership. International players must show international membership credentials.
