Wednesday, March 13, 2024

RULES

Events can be cancelled or combined at the discretion of the tournament committee. No prizes will be awarded for splits, default losses or no-appear, or dumps. The rules of ITTF and USATT policies will govern the tournament. All decisions of the tournament referee are final.

RATINGS CUTOFF

Monday, February 5, 2024 ratings from USATT website will be used for event eligibility. Seedings are based on the most current ratings. Tournament director reserves the rights to assign ratings to unrated players for seeding purposes. Unrated players cannot advance to the prize rounds.

RATINGS FOR DOUBLES

Both players in a doubles team must have either USATT tournament or league ratings. If both tournament and league ratings are available, tournament rating will be used for event eligibility. If a player has no tournament rating, league rating will be used for event eligibility. If neither ratings is available, the doubles team can enter the event but will not be allowed to proceed past the round Robin stage and eligible for award.

U3400D - the combined ratings of both players is less than 3400. No player in a team can have rating above 1900.

U4800D - combined ratings of both players is less than 4800.

DRESS CODE

White shirts or shorts/skirts during play are not allowed. All USATT and ITTF rules and regulations will be followed.

MEMBERSHIP

Proof of USATT membership is required. Membership may be purchased along with tournament entry form. Adult basic membership \$25/year, Pro membership \$75/year. Players who don't want to purchase a full membership may purchase a tournament pass for \$50.

*** You may purchase a tournament pass even if you were previously a USATT member or have never purchased a tournament pass.

FORMAT

Rated Events are Round Robin, the top 2 advance onto the Single Elimination rounds.

DEFAULTS

No prize/prize money shall be awarded for players who default any match/matches. The tournament committee reserves the right to restrict such players (who default their matches) from advancing if no satisfactory reasons are given for their defaults.
