Equipment: Only USATT approved equipment may be used. **TABLES:** Donic and Butterfly. **BALL:** Nittaku Nexcel 3-Star 40+ orange plastic ball, provided complimentary by Paddle Palace.

Rules: Rules of the USATT will govern play. Decisions of the Tournament Committee are final. No orange shirts allowed.

Defaults: Match time is default time.

Ratings: Rating posted on USATT on **Friday, April 9th, 2021** will be used for eligibility. Players must be rated under 2300 to play in U3800 Doubles and under 1700 to play in U2600 Doubles.

Unrated Players: Unrated players can advance in all events.

Format: Singles events will be preliminary round robins of 3 or 4 players with top finisher(s) advancing to a single elimination main draw. Open Singles semi-final & final matches will be 4 out of 7 games to 11 points. All other singles and doubles matches will be 3 out of 5 games to 11 points. Single events with fewer than 4 players will be cancelled. Tournament Committee reserves the right to adjust format and prize money based on number of entries received.

Age Limits: Junior ages are determined as of **April 23rd, 2021**. Senior ages are determined as of **December 31st, 2021**.

Eligibility: Entrants must be 1.) Michigan residents for three months prior to the tournament or 2.) active military personnel stationed in Michigan or 3.) a full-time student going to school in Michigan.
