MEMBERSHIP – This is a 2 star, USATT sanctioned tournament. Mandatory USATT membership or tournament pass may be purchased with entry. Basic Membership is \$25/year and a Pro Membership is \$75/year. Adult tournament passes are \$50 and Junior Tournament passes are \$20.

EQUIPMENT – Donic and Butterfly tables. Wood floor. Nittaku 3-star premium orange plastic (40+) balls. Butterfly/ Donic nets. Only USATT approved equipment.

FORMAT – Singles events with fewer than 4 players (3 teams in doubles) will be canceled. In the Open event (#1), 0 to 5 players will result in event cancellation, 6 to 11 players prize money is reduced to 70 percent. For events (#2, #3 and #4) 0 to 5 players will result in event cancellation, 6 to 9 players prize money is reduced to 70 percent. All singles events are round robins of 4-6 players, followed by single elimination if 2 groups, or round robin final if 3 or more groups. Doubles is single elimination (round robin if only 3 teams). Matches are 3 of 5 games to 11. The most current USATT ratings will be used; all USATT regulations apply. Unrated players can only advance in OPEN and AGE EVENTS. **EVENT TIME IS EVENT DEFAULT TIME.**
