FORMAT: All matches are 3 out of 5 games to 11 points. Depending on the number of entries, the top 2 players from each round-robin group will advance to a final single elimination round. If events have 7 or fewer entries a giant round robin will be played. The tournament director reserves the right to change the draw limit for any event depending on the number of registrants. No prize money awarded for defaults, splits, or unfinished matches. All USATT regulations will apply, including dress code. No white clothing. Players may not enter more than two events.

ENTRY POLICY/RATINGS: USATT ratings as of December 4, 2025 will be used for all events.

ENTRY DEADLINE: Entries must be received by December 4, 2025. Late entries will be accepted with a **\$10** late fee through Omnipong, space permitting.

ELIGIBILITY: Players must be USATT members or members of an ITTF affiliated association. Nonmembers may join the USATT with their entry. The tournament committee may estimate ratings for unrated players, if there is an objective basis, such as a club league rating. Unrated players may **NOT** advance in rated events.

DEFAULT POLICY: Players not signed in within 10 minutes after an event's starting time may be defaulted.

REFUND POLICY: Withdrawal needs to be made by the entry deadline or entry fee will be forfeited.

USATT MEMBERSHIP: \$25/yr Basic Membership (participate in 0-4 star tournaments), \$75/yr for Pro Membership (participate in all USATT events). Any player that is not a current USATT member must either purchase a membership (recommended), or a Tournament Pass for \$20 (Juniors) and \$50 (Adults).
