2. USATT dress code & all other USATT rules will be enforced. Do not wear white clothing as the ball is white.
3. All events will be 3 out of 5 games.
4. **DO NOT ENTER** 2 events with same starting time.
5. Maximum of **3 events PER DAY**.
6. Unrated players may enter any event. However, they are NOT guaranteed to advance from any rating events EXCEPT in Open Singles & Age Events.
7. Players must be USATT members, or join by the tournament date.
8. Age cutoff for Over 40/50 is your age as of 12/31/2023.
Age cutoff for any Junior events is as of 12/31/2023.
9. Ratings as of 11/6/2022 will be used for eligibility. The most recent rating will be used for seeding.
10. **Maximum player rating for U4500 Doubles is 2450 per player & U3800 doubles is 2150 per player.**
11. Any image, photographic or otherwise, of tournament play or with in the official venue is the joint property of USA Table Tennis (USATT) and LYTTC. Entrants agree to allow their voice, image, likeness, and/or any other representation to be broadcast, by USATT and/or LYTTC.
