Ties will be broken in accordance with the USATT Tournament Guide. All matches will be 3 out of 5 games.

SCHEDULE: Play starts at 9:00 am. Players must register no later than 30 minutes prior to start time. Players not on time may be defaulted and or replaced by alternate players.
