- **Entry deadline: June 6, 2021**
- **Equipment:** Butterfly Octet Tables, Butterfly R40 Balls, rubber flooring
- All USATT regulations apply including equipment, conduct, dress, and language.
- All decisions of the tournament referee are final.
- **Ratings:** Cut off date is June 6, 2021. The most recent rating will be used for seeding. Estimated ratings for new players will be accepted from a USATT certified coach. Un-rated players may or may not advance from the preliminary round robin at the discretion of the tournament director.
- **Format:** All events will start with group round robin format followed by single elimination rounds. All matches will follow the 11-point rule and be played in the best of 5 games except Open event semifinals and finals will be played in 4 out of 7.
- **Scheduling:** Events are not guaranteed to complete as scheduled and may be canceled or combined if needed. Refunds will be issued if canceled.
- **Check in time:** At least 30 minutes before event start time.
- **Membership:** USATT membership must be valid through the tournament end date: June 13, 2021.
- **Refund:** Fees will be refunded if the event is canceled. No refunds after entry deadline. No refunds if participant elects to drop out of the tournament or withdraw from an event. There is a \$15.00 processing fee for participants who present a signed doctor's note for the purposes of withdrawal.
- **Defaults:** No prize/prize money shall be awarded for players who default any match/matches. The tournament committee reserves the right to restrict such players (who default their matches) from advancing if no satisfactory reasons are given for their defaults.
