Entry Deadline: Saturday, February 18th, 2023. \$5 additional fee for late entries and entries not paid by February 18th , 2023.

Eligibility For Event: Open to all members of USA Table Tennis (USATT). Non-members may join the USATT by including the membership fee with their entry fee. Players who are not current USATT members may buy a basic Membership for \$25.

Rules: The Laws of Table Tennis as published by the ITTF and all USATT regulations will be enforced.

Rackets - One side of the racket must be bright red or another color recently approved by ITTF, the other side black. No complete regluing unless it is a new sheet of rubber. Partial re-gluing may be done with the permission of and under supervision of the referee.

Clothing - The USATT Dress Code applies. The main color of the body of the shirt or shorts may not be white. Please dress in appropriate athletic attire. Designs or lettering that are distracting to an opponent or are offensive will not be permitted. Rubber-soled, non-marking, shoes must be worn.

Equipment: Butterfly Europa/Centrefold 25 tables/nets, DHS net, Joola 3000sc tables/nets, & Nittaku Premium 3-star 40+mm white plastic balls. Red rubber floor. ITTF/USATT approved equipment only.

Format: Two Round Robins and elimination playoff. Players will be divided into two groups based on player's ratings. There will be 28 players in each group. All players advance. The top players will go into Championship, Class AA, and Class A. The other players will go into Class B, C, D.

Players in Group two must check-in at the control desk before 8:45am, play begins at 9:00am. The control desk will allow check-ins beginning at 8:30am. Players that arrive late may be defaulted for the entire event (and replaced by an alternate). The court will open for practice Friday, 6:00pm-9:00pm on Feb. 24th, 2023. and 8:00 a.m. on Feb. 25th .

Players in Group one must Check-in at the control desk at 10:45am on Feb. 25th , play begins at 11:00am.

Play will be in three stages:

Preliminary: Group two begins at 9:00am. 7 groups of 4 players complete a round robin. Group one begins at 11:00am and 4 players complete round robin.

Stage 2: The 2nd round robin. Based on playing records in the Preliminary group one, top 2 players advance to Championship event in 4 groups of 3 or 4 players each. 3rd one goes to Class AA in 2 groups of 3 or 4 players each. The last one goes to Class A in 2 groups of 3 or 4 players each. The same process is applied to the group two but with Class B, C, and D accordingly.

Stage 3: Begins at approximately 5:00pm. Top 2 in the 2nd round robin from Championship and Class B advance to elimination play off. The top 1 players of other classes advance to elimination. All games will be to 11 points; Championship event best of 7 for final match only; all other matches are best of 5 games.

Cancellation: Director reserves the right to modify any event or cancel the tour. Fees refunded if tour is cancelled by organizer. Refunds available prior to deadline upon player’s request and NO REFUNDS AFTER FEBRUARY 18th. THANK YOU!

Awards: Championship – 1st \$600, 2nd \$300, Semi-finalists \$100 each;
Class AA – 1st \$140, 2nd \$70;
Class A – 1st \$70;
Class B – 1st \$100, 2nd \$50.
Medals for 1st and 2nd in all events.

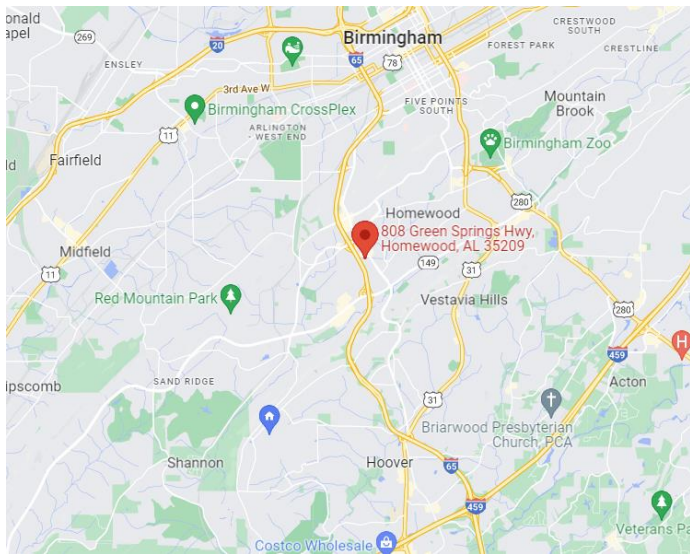
