**Entry Deadline:** Sunday, June 23, 2024. \$5 additional fee for all late entries (Doubles can be also entered on tournament day without late fee).

Eligibility for Event: Open to all members of USA Table Tennis (USATT). Non-members may join the USATT by including the membership fee with their entry fee. Players who are not current USATT members may buy a basic Membership pass for \$25. Championship event is for players with USATT rating over 1300.

**Rules:** The Laws of Table Tennis as published by the ITTF and all USATT regulations will be enforced. Rackets- One side of the racket must be bright red or another color recently approved by ITTF, the other side black. No complete regluing unless it is a new sheet of rubber. Partial re-gluing may be done with the permission of and under supervision of the referee.

Clothing- The USATT Dress Code applies. The main color of the body of the shirt or shorts may not be white. Please dress in appropriate athletic attire. Designs or lettering that are distracting to an opponent or are offensive will not be permitted. Rubber-soled, non-marking, shoes must be worn.

**Equipment:** Butterfly Europa/Centrefold 25 tables/nets, Joola 3000sc tables/nets, & Nittaku Premium 3-star 40+mm white plastic balls. Red rubber floor. ITTF/USATT approved equipment only.

**Format**: 28 player limit per event. Play will be in two stages in each event, Round Robin and single elimination playoff. All events will start with round robin (3 to 5 players a group). Top 2 winners from each group will advance to single elimination playoffs. Championship event is best of 7 for final match. All other matches are best of 5 games.

Players must check-in at the control desk 15 minutes before event start time. Players arriving late may be defaulted for the event and replaced by an alternate. The court will open for participants' practices 7:00pm-9:00pm on Friday & Saturday and 9:00am-9:45am on Saturday & Sunday.

Cancellation: Director reserves the right to modify any event or cancel the event/tour. The event fee will be refunded if the event is cancelled by organizer. \$5 non-refundable fee for cancellations prior to deadline upon player's written request and the event entry fee will be refunded. # USATT SAFE SPORT PROTOCOL ENTRY BLANK TEMPLATE FOR USATT SANCTIONED TOURNAMENTS

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.
I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have <u>regular contact with or authority over</u> minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.

#### PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain **Positions of Authority** must complete SafeSport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). The list of Positions of Authority requiring **Full Safe Sport Compliance** is set out in USATT's Safe Sport Policy and the Athlete Safety Section of the USATT Website: <a href="https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport">https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport</a>.

#### **USATT COACHING POLICY**

All persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be Fully Safe Sport Compliant, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

#### ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, <u>ALL Adult Participants</u> (participants over the age of 18) who have regular contact with or authority over minor aged athletes must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").

#### CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT

USATT is pleased to assist USATT Members in the process of becoming SafeSport Trained and/or Fully Safe Sport Compliant. Please contact USATT at <a href="mailto:Admin@usatt.org">Admin@usatt.org</a> for more information and guidance in this process.

#### MANDATORY REPORTING

There are certain circumstances where **reporting a potential Safe Sport violation is mandatory**. 
