**Rules and Equipment**: All USATT rules will govern play, including USATT dress code and use of only USATT-approved equipment (**www.usatt.org/rules**). Must be a current USATT member (Pro plan - \$75, Basic plan - \$25) to participate. Butterfly 3-star, 40 mm white balls will be used on 10 Butterfly Centerfold 25 tables on a professional rubberized floor with spacious court sizes.

**Event Details**: USATT Sanctioned 2-Star tournament. All matches will be best-of-five games. Winners of each round-robin group will advance into a single-elimination bracket except for Elite Singles (top 2 from each group). \* Some groups in the 8:30 AM events will start at 10:45 AM.
