

Asheville Fall Open Team Tournament

Location: Tempie Avery Montford Community Center, 34 Pearson Drive, Asheville, NC 28801

Team Limit: 20 teams (2-3 players per team)

Equipment: Butterfly blue Centerfold 25 tables with matching nets, Butterfly R40 Premium 3-Star white balls, and wood floor.

Rules: USATT Rules including dress code shall be enforced. The main color of the body of the shirt, shorts, or skirt may not be white. Rubber-soled, non-marking shoes must be worn.

Eligibility: Open to all USATT members. Non-members may enter the tournament by purchasing a USATT Silver or Gold membership on the USATT JustGo platform (usatt.justgo.com). Players must have a valid USATT membership suitable for tournament play BEFORE they enter the tournament. Memberships are not available for purchase on Omnipong or at the tournament site.

Non-rated players may enter and participate; however, teams with non-rated players may not receive cash prizes.

To Enter: Register via [Omnipong.com](https://omnipong.com), online entry only.

Entry Fee: \$100 per team + \$3 per player USATT Rating Fee

Entry Deadline: December 2, 2026. No refund will be granted after December 2, 2026.

Officials: Tournament Director: Steven Hitchner

Tournament Umpire: Steven Hitchner, CU

Start Time: Doors open and check-in begins at 8:45. Tournament play begins at 9:30..

Format: This is a single-stage round-robin event. Teams will be placed in Division A, B, C, or D based on the team rating. A team's rating will be determined by adding together the USATT ratings of the two top-rated players on the team. Each Division will have 5 teams. Teams will play a round robin within the Division with matches played in the following order: A vs. X, B vs Y, two players from team 1 vs. two players from team 2, A vs.Y, and B vs. X. All five matches in each team tie will be played regardless of the outcome. The team with three match wins will win the team tie.

Cancellation: The Tournament Director reserves the right to modify or cancel any event or prize award. The event fee will be refunded if the event is canceled by the Tournament Director. Player entry fees will be refunded upon the Tournament Director's receipt of a player's written request before the deadline. No refunds will be granted after the deadline
