Trophies to 1st, 2nd, and 3rd in all Divisions. This is an official USATT sanctioned tournament. Unrated players, or players with an estimated rating, will not be eligible for awards.

Players may check-in beginning at 8:00 AM until 8:45 AM. **Play will begin at 9:15 AM Sharp.**

Players not on time for the tournament may be defaulted for the entire event (and replaced by an alternate) at the discretion of the tournament director.

DIRECTIONS TO VENUE:

North Bound on I-95:

Take exit 345 (Bowden Road) - Right on Bowden. **Get in left lane very quickly (about 150 feet)** – Left on Spring Park Rd. Arrive at Pine Castle at 4911 Spring Park Road on the right (less than a quarter mile from University Blvd).

South Bound on I-95:

Take Exit 346A onto West Bound University Blvd. - Left on Spring Park Rd (First road on left after going back under I-95). Arrive at Pine Castle at 4911 Spring Park Road on the right (less than a quarter mile from University Blvd).

East Bound on I-10:

South on I-95 S towards Jax Beaches/Daytona Beach then follow South Bound Directions
Follow South Bound on I-95 Directions
