**CANCELLATION/CHANGE: Tournament officials reserve the right to cancel any event or combine events if there are insufficient entries. Round Robin size and advancement will be determined by entry numbers.*

FORMAT: All matches are 3 out of 5 games to 11 points. Depending on the number of entries, the top 2 players from each round-robin group will advance to a final single elimination round. If events have 7 or fewer entries a giant round robin will be played. The tournament director and officials reserve the right to change the draw limit for any event depending on the number of registrants. No prize money and/or trophies awarded for defaults, splits, or unfinished matches. All USATT regulations will apply, including dress code. **No white clothing.**

ELIGIBILITY:

Events 1-6: All events are rated events. Players must be USATT members. Nonmembers may join the USATT with their entry. The tournament committee may estimate ratings for unrated players, if there is an objective basis, such as a club league rating. Unrated players may *NOT* advance in rated events. Players are eligible if their rating is below the rating listed for the event or they are unrated.

Event 7: Open doubles is an unrated event with a \$10 fee per person. Open for all players.

ENTRY POLICY/RATINGS: USATT ratings as of June 14, 2025 will be used for all events.

ENTRY DEADLINE: Entries must be received by June 12, 2025. Late entries will be accepted with a \$10 late fee through Omnipong, space permitting. Payments must be made on or before June 12, 2025 for tournament participation.

DEFAULT POLICY: Players not signed in within 10 minutes after an event's starting time may be defaulted.

REFUND POLICY: Withdrawal needs to be made by the entry deadline or entry fee will be forfeited.

PRIZES: Cash prize / trophies for 1st and 2nd place.
