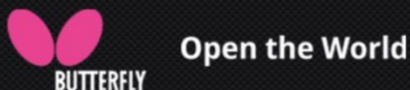

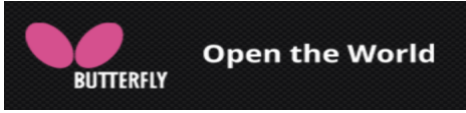

## Rules and Policies

- All ITTF and additional USATT regulations apply. Only ITTF and USATT approved equipment will be used: 10 blue Butterfly Centerfold Table Tennis Table with net and Butterfly white 3-star R40+ Prime plastic balls.

- Tournament management reserves the right to modify, combine, or cancel events, limit total participants or total entries by event. If event(s) are cancelled the fees for this event will be refunded.
- To be eligible to enter the Venue and/or participate at the tournament, a person Should be in good standing with the [USATT](#) and [SafeSport Organization](#).
- **Starting from June 27<sup>th</sup>, 2026, players who have not made the entry fee payment will be removed from the participant list automatically and the spot will be made open to the next paying participant. Platforms like Omni Pong and or stadium compete may not reflect the actual list of participants and number of available spots which are maintained separately by CITTA organizing committee**
- Players must register at the desk or check in online at stadium compete no later than 30 minutes before the starting time of their respective event(s). **Default time is the starting time for the event and/or the match time.**
- **No prizes will be awarded for splits, defaults and no-shows. Unrated Players are not eligible to win trophy and prize money in rating events 2-8. If a player defaults a match, then the player is defaulted from the following matches and the event.**
- The Venue will be open for practice/warmup from 7:30 am. Pre-match warm-up will be limited to 2 minutes.
- Draws will be posted online at [www.stadiumcompete.com](http://www.stadiumcompete.com) 15 minutes before the start time of respective events. Single Elimination start time will be announced at the start of the respective events.
- All events will start with a round robin (RR) group of 3 to 4 players followed by Single Elimination. For Events 2-7 **only one (1) rated player advances** out of each RR group to Single Elimination (SE)
- **Except for Open, Unrated players (players playing in their first USATT tournament) cannot advance from group stages to Single Elimination rounds.**
- Unrated players will be given an estimated rating based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible. Unrated players may not win prize money or trophies except for the Open Event
- Withdrawals through July 6<sup>th</sup>, 2025, will be eligible for full refunds. After that date refunds will only be issued if there is someone on the waiting list who fills the vacated spot and / or other situations approved by USATT. No Refunds for now shows
- Any image, photographic, video or otherwise, taken of the tournament play or within the official venue is essentially the property of CITTA (Chicago International Table Tennis Academy) and

USATT. Entrants agree to allow their picture, video, voice and likeness to be reproduced in connection with CITTA or USATT by way of any medium

- The most recent ratings available will be used for seeding the events
- **Event Eligibility Rating Date is June 12<sup>th</sup>, 2026**
- All matches are best of 3 out of the 5 games to 11 points as per ITTF/USATT rules
- No Food allowed inside Field of Play (FOP). Dry Snacks are fine. Drinks are not allowed inside the courts. Please use the lobby for eating and drinking. Drinking Water Faucet is not available at the facility. We recommend getting your own water and/or purchase through vending machines available onsite.
- USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball (white). **No white shirts, shorts and skirts allowed. Tracksuits, Hoodies, Jeans etc. are not allowed during matches. Only ITTF and USATT approved clothing. Dress Shoes and non-Court shoes not allowed on courts. All Court shoes should have non-marking soles.**
- All Trophies must be picked up at the control desk. Trophy will not be shipped.
- **Items Not Allowed inside the Venue or Field of Play: USOC and USATT** have strict policies which don't allow Players and Spectators to bring Firearms, Tobacco products, Smoking products including E-Cigarettes and Vaping products, Alcohol, VOC glues including around minors. Gluing Racket is not permitted inside the Venue. Persons who violate will be automatically Disqualified and removed from the tournament and Venue.

**IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin, I ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand the nature of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activities.**

**FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT**

I give my consent to participate in all emergency transportation associated with activities during this table tennis tournament, in the event I become incapacitated or otherwise not conscious to give direct consent, and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.**

#### **USATT COACHING POLICY**

All persons who are engaged in **coaching activities** at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, **except parents or legal guardians coaching their own children**, must be **Fully Safe Sport Compliant**, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

**ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING**

Pursuant to USATT’s Minor Athlete Abuse Prevention Policy, **ALL Adult Participants** (participants over the age of 18) **who have regular contact with or authority over minor aged athletes** must complete SafeSport Training offered by the US Center for SafeSport every year (“SafeSport Trained”).
