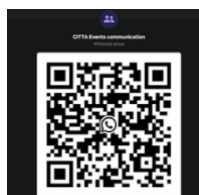

Format :

- Two Persons per team. No more than two players per team and substitutions not allowed
- Two Stage RR: Initial First Stage for division placements and second stage for Division playoffs
- All events have a Max of 16 teams and will be split into groups of 4 across 4 groups. After initial Round Robin all teams from each group advance to Divisions A, B, C and D based on their respective placements in initial groups.
- First Stage RR will be 2 out 3. Second Stage RR will be 3 out 5. Doubles will be the deciding match after all singles matches. Coin flip for A/B or X/Y
- First Stage (2/3): A vs Y, B vs X, AB vs XY
- Second Stage (3/5): A vs Y, B vs X, A vs X, B vs Y and AB vs XY

Rules and Policies

- All ITTF and additional USATT regulations apply. Only ITTF and USATT approved equipment will be used: 8 Blue Butterfly Centerfold Table Tennis Table with net and Butterfly white 3-star R40+ Prime plastic balls. All courts are individually Barrired.

- Tournament management reserves the right to modify, combine, or cancel events, limit total participants or total entries by event. If event(s) are cancelled the fees for this event will be refunded.
- To be eligible to enter the Venue and/or participate at the tournament, a person Should be in good standing with the [USATT](#) and [SafeSport Organization](#).
- **Event Eligibility Rating Date is August 1st, 2026, for all rated events.**
- Max Rating allowed for a player for the respective rated events below:

Maximum individual player ratings are: U4000: 2099; U3200: 1699; and U2400: 1299. A team's combined rating, calculated by adding the ratings of both players, must not exceed 3999 for U4000, 3199 for U3200, and 2399 for U2400, based on the August 1st, 2026, ratings.
- **Starting from September 1st, 2026, Teams (participants) who have not made the entry fee payment will be removed from the participant list automatically and the spot will be made open to the next paying Team (participants). Platforms like Omni Pong and or stadium compete may not reflect the actual list of participants and number of available spots which are maintained separately by CITTA organizing committee**
- Players must register at the desk or check in online at stadium compete no later than 30 minutes before the starting time of their respective event(s). **Default time is the starting time for the event and/or the match time.**
- **No prizes Money and/or Medals/Trophies will be awarded for splits, defaults and no-shows. Teams with Unrated Players are eligible to win Medals/Trophy and prize money. Team (s) with Unrated player(s) have to contact tournament director and referee to confirm eligibility for rated events.**
- The Venue will be open for practice/warmup from 8:00 am. Pre-match warm-up will be limited to 2 minutes.

- Draws will be posted online at www.stadiumcompete.com 15 minutes before the start time of respective events.
- Trophies and prize money awards are based on the final standings in the group RR group.
- All matches are best of 3 out of the 5 games to 11 points as per ITTF/USATT rules
- Unrated players will be given an estimated rating based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible. Unrated players and team captains must contact Referee for seeding at the earliest.
- Withdrawals through September 12th, 2026, will be eligible for Event Fee and Ratings Fee refunds. After September 12th, 2026, refunds will only be issued if there is someone on the waiting list who fills the vacated spot and / or other situations approved by USATT. No Refunds for now shows. Registration Fee will not be refunded at any time.
- The most recent ratings available will be used for seeding the events on the day
- Any image, photographic, video or otherwise, taken of the tournament play or within the official venue is essentially the property of CITTA (Chicago International Table Tennis Academy) and USATT. Entrants agree to allow their picture, video, voice and likeness to be reproduced in connection with CITTA or USATT by way of any medium
- No Food allowed inside Field of Play (FOP). Dry Snacks are fine. Drinks are not allowed inside the courts. Please use the lobby for eating. Drinking Water Faucet is not available at the facility. We recommend getting your own water and/or purchase through vending machines available on premise.
- USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball (white). **No white shirts, shorts and skirts allowed. Tracksuits, Hoodies, Jeans etc. are not allowed during matches. Only ITTF and USATT approved clothing. Dress Shoes and non-Court shoes not allowed on courts. All Court shoes should have non-marking soles.**
- All Trophies must be picked up at the control desk. Medals/Trophy will not be shipped.
- **Items Not Allowed inside the Venue or Field of Play: USOC and USATT** have strict policies which don't allow Players and Spectators to bring Firearms, Tobacco products, Smoking products including E-Cigarettes and Vaping products, Alcohol, VOC glues including around minors. Gluing Racket is not permitted inside the Venue. Persons who violate will be automatically Disqualified and removed from the tournament and Venue.

IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin, I ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand the nature of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activities.

FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT

I give my consent to participate in all emergency transportation associated with activities during this table tennis tournament, in the event I become incapacitated or otherwise not conscious to give direct consent, and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.

ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, **ALL Adult Participants** (participants over the age of 18) **who have regular contact with or authority over minor aged athletes** must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").
